

ChipMOS REPORTS MAY 2018 REVENUE

HSINCHU, Taiwan, June 8, 2018 /PRNewswire-FirstCall/ -- ChipMOS TECHNOLOGIES INC. ("ChipMOS" or the "Company") (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of May 2018. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$29.99 to US\$1.00 as of May 31, 2018.

Revenue for the month of May 2018 was NT\$1,522.3 million or US\$50.8 million, an increase of 7.3% from the month of April 2018 and a decrease of 0.2% from the same period in 2017. The Company noted it is benefitting from a healthy business environment, with multiple new OLED, TDDI and 3D sensing programs now ramping and continued growth in the Company's DRAM services business.
