

ChipMOS REPORTS APRIL 2019 REVENUE

HSINCHU, Taiwan, May 7, 2019 /PRNewswire-FirstCall/ -- ChipMOS TECHNOLOGIES INC. ("ChipMOS" or the "Company") (Taiwan Stock Exchange: <u>8150</u> and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of April 2019. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$30.91 to US\$1.00 as of April 30, 2019.

Revenue for the month of April 2019 was NT\$1,559.5 million or US\$50.5 million, a decrease of 1.5% from the month of March 2019 and an increase of 9.9% from the same period in 2018. The Company noted that it benefitted from near full utilization of its COF and its DDIC wafer test capacity, combined with growth in both TDDI and new NAND flash business. These improvements were partially offset due to one less calendar day of operations in the month of April compared to March.
