

ChipMOS REPORTS OCTOBER 2019 REVENUE; 8.5% GROWTH MONTH OVER MONTH

HSINCHU, Nov. 6, 2019 /PRNewswire-FirstCall/ -- ChipMOS TECHNOLOGIES INC. ("ChipMOS" or the "Company") (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of October 2019. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$30.44 to US\$1.00 as of October 31, 2019.

Revenue for the month of October 2019 was NT\$1,898.9 million or US\$62.4 million, an increase of 8.5% from the month of September 2019 and an increase of 4.7% from the same period in 2018. The Company noted that it is benefiting from increasing demand with healthy customer inventory levels. Demand remains strong in the Company's NOR Flash revenue business, with continued growth in its DRAM businesses.
