**ChipMOS REPORTS APRIL 2018 REVENUE**

**Hsinchu, Taiwan, May 10, 2018** - ChipMOS TECHNOLOGIES INC. (“ChipMOS” or the “Company”) (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (“OSAT”), today reported its unaudited consolidated revenue for the month of April 2018. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$29.60 to US\$1.00 as of April 30, 2018.

Revenue for the month of April 2018 was NT\$1,419.1 million or US\$47.9 million, a decrease of 3.0% from the month of March 2018 and a decrease of 11.5% from the same period in 2017.
