



ChipMOS REPORTS JUNE 2010 REVENUE

Hsinchu, Taiwan, July 19, 2010 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month and quarter ending June 30, 2010.

Revenue for the month of June 2010 was NT\$1,576.9 million or US\$48.9 million, an increase of 2.3% from the month of May 2010 and an increase of 52.9% from the same period in 2009. On a quarterly basis, revenues for the second quarter of 2010 was NT\$4,498.4 million or US\$139.4 million, an increase of 22.5% from the first quarter of 2010 and an increase of 53.4% from the same period in 2009. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.27 against US\$1.00 as of June 30, 2010.)
