ChipMOS REPORTS OCTOBER 2013 REVENUE

Hsinchu, Taiwan, November 8, 2013 - ChipMOS TECHNOLOGIES (Bermuda) LTD. (“ChipMOS” or the “Company”) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (“OSAT”), today reported its unaudited consolidated revenue for the month of October 2013.

Revenue for the month of October 2013 was NT\$1,635.5 million or US\$55.6 million, a decrease of 2.7% from the month of September 2013 and a decrease of 4.4% from the same period in 2012. All U.S. figures in this release are based on the exchange rate of NT\$29.42 to US\$1.00 as of October 31, 2013.
