ChipMOS REPORTS FEBRUARY 2016 REVENUE

Hsinchu, Taiwan, March 10, 2016 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of February 2016.
