Hsinchu, Taiwan, September 17, 2008 – ChipMOS TECHNOLOGIES (Bermuda) LTD. (“ChipMOS” or the “Company”) (NASDAQ: IMOS) today reported its unaudited consolidated revenues for the month of August 2008.

Revenues for the month of August 2008 were NT\$1,505.5 million or US\$47.7 million, a decrease of 3.2% from the month of July 2008 and a decrease of 24.4% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$31.55 against US\$1.00 as of August 29, 2008.)
