**ChipMOS REPORTS OCTOBER 2017 REVENUE**

**Hsinchu, Taiwan, November 9, 2017** - ChipMOS TECHNOLOGIES INC. (“ChipMOS” or the “Company”) (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (“OSAT”), today reported its unaudited consolidated revenue for the month of October 2017.

Revenue for the month of October 2017, was NT\$1,537.1 million or US\$51.0 million, an increase of 0.2% from the month of September 2017 and a decrease of 1.6% from the same period in 2016. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$30.12 to US\$1.00 as of October 31, 2017.
