



ChipMOS REPORTS AUGUST 2007 REVENUE

Hsinchu, Taiwan, September 14, 2007 – ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of August 2007.

Revenue for the month of August 2007 was NT\$1,990.1 million or US\$60.3 million, an increase of 4.2% from the month of July 2007 and an increase of 12.5% from the same period in 2006. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$33.00 against US\$1.00 as of August 31, 2007.)
