#### **ChipMOS REPORTS JANUARY 2019 REVENUE**

**Hsinchu, Taiwan, February 15, 2019** - ChipMOS TECHNOLOGIES INC. ("ChipMOS" or the "Company") (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of January 2019. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$30.69 to US\$1.00 as of January 31, 2019.

Revenue for the month of January 2019 was NT\$1,549.9 million or US\$50.5 million, an increase of 0.8% from the month of December 2018 and an increase of 15.9% from the same period in 2018.
