**ChipMOS REPORTS NOVEMBER 2012 REVENUE**

**Hsinchu, Taiwan, December 14, 2012** - ChipMOS TECHNOLOGIES (Bermuda) LTD. (“ChipMOS” or the “Company”) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of November 2012.

Revenue for the month of November 2012 was NT\$1,611.5 million or US\$55.4 million, a decrease of 5.8% from the month of October 2012 and an increase of 5.7% from the same period in 2011. All U.S. figures in this release are based on the exchange rate of NT\$29.07 to US\$1.00 as of November 30, 2012.
