

ChipMOS REPORTS NOVEMBER 2015 REVENUE

HSINCHU, Taiwan, Dec. 10, 2015 /PRNewswire-FirstCall/ -- ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ("OSAT"), today reported its unaudited consolidated revenue for the month of November 2015.Â

Revenue for the month of November 2015 was NT\$1,576.7 million or US\$48.5 million, a decrease of 1.7% from the month of October 2015 and a decrease of 19.1% from the same period in 2014. All U.S. figures in this release are based on the exchange rate of NT\$32.53 to US\$1.00 as of November 30, 2015.
