ChipMOS REPORTS JULY 2016 REVENUE

Hsinchu, Taiwan, August 10, 2016 - ChipMOS TECHNOLOGIES (Bermuda) LTD. (“ChipMOS” or the “Company”) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (“OSAT”), today reported its unaudited consolidated revenue for the month of July 2016.

Revenue for the month of July 2016 was NT\$1,621.9 million or US\$51.0 million, an increase of 0.2% from the month of June 2016 and a decrease of 0.9% from the same period in 2015. All U.S. figures in this release are based on the exchange rate of NT\$31.82 to US\$1.00 as of July 29, 2016.
