# **ChipMOS REPORTS APRIL 2007 REVENUE**

Hsinchu, Taiwan, May 16, 2007 – ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of April 2007.

Revenue for the month of April 2007 was NT\$1,960.5 million or US\$58.9 million, a decrease of 0.3% from the month of March 2007 and an increase of 23.7% from the same period in 2006. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$33.310 against US\$1.00 as of April 30, 2007.)
