

ChipMOS REPORTS OCTOBER 2012 REVENUE

Hsinchu, Taiwan, November 20, 2012 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of October 2012.

Revenue for the month of October 2012 was NT\$1,710.7 million or US\$58.6 million, an increase of 3.6% from the month of September 2012 and an increase of 5.4% from the same period in 2011. All U.S. figures in this release are based on the exchange rate of NT\$29.20 to US\$1.00 as of October 31, 2012.
