

ChipMOS REPORTS FEBRUARY 2010 REVENUE

Hsinchu, Taiwan, March 15, 2010 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of February 2010.

Revenue for the month of February 2010 was NT\$1,131.2 million or US\$35.2 million, a decrease of 9.1% from the month of January 2010 and an increase of 44.8% from the same period in 2009. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.12 against US\$1.00 as of February 26, 2010.)
