

## ChipMOS REPORTS AUGUST 2009 REVENUE

Hsinchu, Taiwan, September 15, 2009 - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of August 2009.

Revenue for the month of August 2009 was NT\$1,112.2 million or US\$33.8 million, an increase of 2.4% from the month of July 2009 and a decrease of 26.1% from the same period in 2008. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.91 against US\$1.00 as of August 31, 2009.)
