**ChipMOS REPORTS APRIL 2012 REVENUE**

**Hsinchu, Taiwan, May 18, 2012** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ("ChipMOS" or the "Company") (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of April 2012.

Revenue for the month of April 2012 was NT\$1,581.6 million or US\$54.3 million, an increase of 4.5% from the month of March 2012 and an increase of 4.7% from the same period in 2011. All U.S. figures in this release are based on the exchange rate of NT\$29.15 to US\$1.00 as of April 30, 2012.
