ChipMOS REPORTS RECORD AUGUST 2021 REVENUE; 26.1% GROWTH YEAR OVER YEAR

Hsinchu, Taiwan, September 10, 2021 - ChipMOS TECHNOLOGIES INC. (“ChipMOS” or the “Company”) (Taiwan Stock Exchange: 8150 and NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services (“OSAT”), today reported its unaudited consolidated revenue for the month of August 2021, with 26.1% year over year growth to a new record revenue level for the month of August. All U.S. dollar figures cited in this press release are based on the exchange rate of NT\$27.66 to US\$1.00 as of August 31, 2021.

Revenue for the month of August 2021 was NT\$2,399.3 million or US\$86.7 million, an increase of 26.1% compared to August 2020 and a decrease of 0.8% compared to July 2021. The Company noted a further strengthening in its memory test and bumping businesses, as it continues to maintain high utilization level.
